- Baliff (Law enforcement shirt)

**Time:** 15 mins.

## **Props:**

- Plaintiff table/desk and chair
- Podium for Judge
- Attorney briefcase and case papers
- Judge court papers
- Judge gavel
- Purse and make-up accessories
- Bible for Baliff

**Director’s Note:** “Me” and “Myself” are spiritually different people within the same physical person. At times, I substitute the name “Aye” to refer to the person “I”, to clarify that the reference is to another person and not oneself.

INTERIOR COURTROOM - DAY

THE ATTORNEY (CARRYING A LARGE BRIEFCASE) AND MRS. ANDERSON ENTER. MRS. ANDERSON TAKES A SEAT AT THE PLAINTIFF TABLE. THE ATTORNEY OPENS HER BRIEFCASE AND PLACES STACKS OF PAPER ON THE TABLE.

**ATTORNEY**

Mrs. Anderson, I need to let you know,  
this will not be easy.

**MRS. ANDERSON**

I know, but I've put this off long  
enough. I have to do something.

**ATTORNEY**

I understand.

**MRS. ANDERSON**

Do you think the judge will rule in my  
favor?

**ATTORNEY**

I don't know. You are making a very  
unusual request. (reaches out to touch  
her shoulder). I promise to do my very  
best.

**MRS. ANDERSON**

Thank you.

**BALIFF**

The Honorable Judge [name of cast  
member]. All rise.

THE JUDGE ENTERS (CARRYING A FOLDER WITH PAPERS)

JUDGE TAKES HER SEAT.

**BALIFF**

You may be seated.

**JUDGE**

Good Morning Counselor.

**ATTORNEY**

Good Morning Your Honour.

**JUDGE**

(Reading) This is case number 237

Anderson vs. Andersons, correct?

**ATTORNEY**

Yes Your Honour.

**JUDGE**

Are all parties here?

**ATTORNEY**

Yes, Your Honour.

**JUDGE**

You may proceed.

**ATTORNEY**

(Steps forward to speak) Your Honour, my client is before the court this morning seeking a restraining order against two individuals whom, over many years and to this day, continue to harass my client, causing great emotional distress. My client seeks relief from this abuse by the issuance of a permanent restraining order preventing these individuals from ever communicating with her again.

**JUDGE**

Very well. Call your first witness.

**ATTORNEY**

I would like to call my client to the stand.

MRS. ANDERSON STANDS NEXT TO THE WITNESS CHAIR.

MRS. ANDERSON TAKES A SEAT NEXT TO THE JUDGE.

**ATTORNEY**

Please state your name for the record.

**MRS. ANDERSON**

(In a sweet delicate voice) Mrs. Aye  
Anderson

**ATTORNEY**

And where do you live?

**MRS. ANDERSON**

I live at 827 Pine Street.

**ATTORNEY**

And who else lives there with you?

**MRS. ANDERSON**

Two boarders; Mee and Myself.

**ATTORNEY**

So, it's only the three of you?

**MRS. ANDERSON**

Yes; Mee, Myself, and I.

**ATTORNEY**

And how long have you known Mee and  
Myself?

**MRS. ANDERSON**

All my life, we practically grew up  
together.

**ATTORNEY**

So they were good friends at first.

**MRS. ANDERSON**

Oh Yes, we did everything together. We  
attended school together;

MRS. ANDERSON(cont'd)

hung out at parties...we all got married  
the same time. We were inseparable.

**ATTORNEY**

What happened?

**MRS. ANDERSON**

Well, as "I" got older, I wanted to grow  
more spiritually, so I accepted Christ  
and joined a church. That's when things  
started to change.

**ATTORNEY**

Explain.

**MRS. ANDERSON**

Well, actually I changed. I use to do  
bad when I was by Myself. So I decided

didn't like that.

**ATTORNEY**

What happened?

**MRS. ANDERSON**

Myself became angry.

**ATTORNEY**

Why?

**MRS. ANDERSON**

mind, but I decided to join [name of  
church]. When Myself found out what I  
did she started harassing me.

**ATTORNEY**

Did you harassed her in any way?

**MRS. ANDERSON**

SHE BECOMES EMOTIONAL AND TAKES OUT A TISSUE TO WIPE HER TEARS.

**ATTORNEY**

**JUDGE**

Very well, (to Mrs. Anderson) You may step down.

AN EMOTIONAL MRS. ANDERSON STEPS DOWN AND TAKES HER SEAT.

**JUDGE**

(to Attorney) Please call your next witness.

**ATTORNEY**

I call Mrs. Mee Anderson to the stand.

MRS. ANDERSON RETURNS, BUT THIS TIME AS A DIFFERENT PERSON (VERY FLIRTATIOUS, MEN-CHASER)

**BALIFF**

Raise your right hand and place your left hand on the bible. Do you promised to tell the truth, so help you God?

**MRS. ANDERSON**

Sure. (Flirting with Baliff) You're kinda' cute.

**BALIFF**

Please be seated.

**ATTORNEY**

Please state your name for the record.

**MRS. ANDERSON**

Mrs. Mee Anderson.

MRS ANDERSON TAKES OUT A COMPACT MIRROR TO ADMIRE HOW SHE LOOKS AND ADJUST HER HAIR AND MAKE-UP DURING THE CONVERSATION.

**ATTORNEY**

And where do you live?

**MRS. ANDERSON**

Well, my mailing address is 827 Pine Street..(thinking about her many boyfriends) but I like to move around, if you know what I mean.

**ATTORNEY**

And who else lives at Pine Street with you?

**MRS. ANDERSON**

Just Myself and Aye.

**ATTORNEY**

Now Mrs. Anderson, Aye testified the you were jealous of her because she accepted Christ. Is this true?

**MRS. ANDERSON**

(Shocked) I'm not jealous of her! Just look at her...and look at me (posing). If anything, she is jealous of me.

**ATTORNEY**

Is it true that you and the plaintiff  
use to be known as the "party girls"?

**MRS. ANDERSON**

Oh yeah...we had some good times...club

**ATTORNEY**

**BALIFF**

**MRS. ANDERSON**
